



OBTAINING A GREEN PASS IN ITALY WITH THE RECOGNITION OF A VACCINATION (APPROVED BY EMA) MADE ABROAD

1. If you are not already registered with the Italian National Healthcare System, please register at the ASL (Local Healthcare Authority) counter in the Camerino Hospital, located at the address *Caselle 1* (yellow building above the hospital), exhibiting a valid identification document.
2. Once registered with the Italian National Healthcare System, go to the ASL counter in the San Severino Hospital, located at the address *Via Glorioso n. 8* (red building adjacent to the hospital). The counter is open on Mondays, Tuesdays, Thursdays and Fridays from 9:00 a.m. to 1 :00 p.m. You will need to exhibit the following documents:
 - Vaccination certificate in the original format, showing the personal data of the holder (name, surname, date of birth), the data relating to the vaccine(s) received (name and batch), date(s) of administration of the vaccine(s), and the identification data of the issuer of the certificate (State, Healthcare Authority). The original certificate must be in English language. In the original is issued in a language different from English, it must be accompanied by a certified translation.
 - Identification document
 - Tax Code card (if you have one)
3. After having carried out steps 1 and 2, you will receive a text message or an email with an Authcode, with which you can download the Green Pass by clicking the following link: <https://www.dgc.gov.it/spa/public/home>, and selecting the item "*utente senza tessera sanitaria o vaccinato all'estero*" (user without a national healthcare card or vaccinated abroad)

OBTAINING A GREEN PASS IN ITALY WITH THE RECOGNITION OF A CERTIFICATE OF HEALING OBTAINED ABROAD

1. you are not already registered with the Italian National Healthcare System, please register at the ASL (Local Healthcare Authority) counter in the Camerino Hospital, located at the address *Caselle 1* (yellow building above the hospital), exhibiting a valid identification document.
2. Once registered with the Italian National Healthcare System, go to the ASL counter in the San Severino Hospital, located at the address *Via Glorioso n. 8* (red building adjacent to the hospital). The counter is open on Mondays, Tuesdays, Thursdays and Fridays from 9:00 a.m. to 1 :00 p.m. You will need to exhibit the following documents:
 - Certificate of healing issued by a foreign Healthcare Authority in the original format, showing the personal data of the holder (name, surname, date of birth), information about the holder's previous SARS-CoV-2 infection following a positive test (date of first positive molecular swab), and the identification data of the issuer of the certificate (State, Healthcare Authority). The original certificate must be in English language. In the original is issued in a language different from English, it must be accompanied by a certified translation.
 - Identification document
 - Tax Code card (if you have one)
3. After having carried out steps 1 and 2, you will receive a text message or an email with an Authcode, with which you can download the Green Pass by clicking the following link: <https://www.dgc.gov.it/spa/public/home>, and selecting the item "*utente senza tessera sanitaria o vaccinato all'estero*" (user without a national healthcare card or vaccinated abroad)
